FIRST AMENDMENT TO THE

McGAVRAN CHARITABLE TRUST DATED MARCH 2, 1989

- TO: THE FULLER FOUNDATION, TRUSTEE
- FROM: DONALD A. McGAVRAN, GRANTOR
- RE: CHANGES IN CHARITABLE DISTRIBUTIONS AND INVESTMENT INSTRUCTIONS.

Pursuant to the powers retained by the Grantors in ARTICLE FOUR of the McGavran Charitable Trust to revoke, amend, or make additions to the Trust.

NOW THEREFORE Donald A. McGavran does hereby exercise such power

and amend the Trust as follows:

I.

Replace items d(i), (1)-(7) in Article VI, paragraph 2 of the
Trust with new items d(i), (1)-(7) which shall read as follows:
 (d) The remaining assets shall be retained by the Trustee, with
power to substitute Fuller Theological Seminary at any time, as a
designated endowment on the following terms:

(i) For twenty years after Donald's death, the income shall be distributed to the following religious organizations in the indicated percentages:

(4) Church Growth Research Centre, Post Bag 768,Kilpauk, Madras 600 010, India: 24%

II.

Add to Article VII a new item hereinafter referred to as item (j) which shall read as follows:

(j) The Trustee shall endeavor to maintain the historic dollar value of the assets referred to in Article 6.2(d) for

twenty years including, if necessary, a reduction in the

amount distributed annually to the named charities. Such

calculations shall be on a total return basis.

Dear Mr. Joseph:

Thank you for your letter dated March 3, 1992 regarding the Church Growth Association of India and the Church Growth Research Center. I understand from your letter that you are the

auditors for this organization and were inquiring in that capacity regarding the status of the Center's eligibility for funds under the Donald A. McGavran Trust.

On or about the date of this letter, I have forwarded a check in the amount of \$23,040 dollars to the Conservative Baptist Foreign Missions Society to the attention of Rev. Leonard Tuggy to be placed in the Church Growth Research Center account which they maintain. As you know, CGRC is one of the approved ministries for the CBFMS. Because we have not been provided with evidence that the CGRC or the Church Growth Association of India are recognized as tax exempt organizations in the United States, we have used a US based qualified ministry with proper Internal Revenue Service standing as a 501(c)(3) or 170(b) organization.

As a fiduciary of this Trust, I do need to receive either from you on heir behalf or directly from the Church Growth Research Center an annual accounting of how the funds are used as well as an audited financial statement in order to be able to determine their continued eligibility for annual distributions. I am also requesting that you forward to me a copy of the most recently completed independent audit of the organization for my records. I have forwarded the funds to the Conservative Baptist Foreign Mission Society on the assumption that the above requested information will be forthcoming.

Dear Sir,

We hereby inform you that you should repay the undermentioned sum of rupees immediately failing which we are forced to take legal action to recover the same alongwith the litigation expenses.

On 28th April 1994 we advanced you a sum of Rupees Two Thousand (Rs.2,000/-) to book two AC second class Train Tickets from Madras to Howrah in Coromandal Express Train for 1) Dr.Roger E.Hedlund and 2) Mrs.June Hedlund for the journey on 12th June 1994. On receipt of money, you assured us that the Train Tickets would be booked and delivered to us in a day or two. When our office assistant, Jayachandran, approached you after two days, you informed k him that 12th June 1994 was wait-listed. He is turn requested you to book the Tickets for 11th June 1994 and for which you have agreed. When he approached you after another two days to collect the tickets, he was informed by you that the Tickets were placed under RAC 1 & 2. In fact the tickets were not at all booked by you. When he inquired you after another two days, you told him the same lie and never cared to book the Tickets. Subsequently he went on demanding for the tickets everyday but you have not bothered to book the journey tickets and hand it over to him.

On 6th Junc 1994, Mrs. June Hedlund visited your office to collect the tickets. You were not there in the office and the tickets were not booked. She left a note requesting to hand over the tickets immediately. On 6th June when she contacted your office over phone around 10:00 in the morning and demanded for the tickets to be delivered before 1:00 p.m., it was not done. When we duputed our assistant, Jayachandran, to go over to your office around 6:00 p.m. the same day to find out the position, he reported us that the tickets were booked only on 8th June 1994 at 16:49 hours for the journey on 12th June 1994 and we were kept wait-listed as 49 & 50. He refused to take the tickets since it was booked on the wrong date and the lest minute and requested you to repay the

In the meantime, we made arrangements to mack our luggages to i book it in the percel van, to meet us at Howreh Station and other plans and programmes m accordingly at Madras and Calcuta. When we came to know at the last hour, that the tickets were not booked for 11th June as assured by you, we mere subjected to a lot of inconveniences and hardships. Mrs.June Hedlund rushed to the Station to get an emergency quota and spent two days and able to get just one ticketonly. Dr.Roger E.Hedlund could not able to accompany her and happened to fly to calcutta to be in time to take-up his assignment.



Please note if the said money is not returned within two days on receipt of this letter, we are constrained to take legal proceedings on you to recover the same.


