### MINUTES OF MEETING OF BOARD OF TRUSTEES Indian Springs Holiness Camp Ground Monday, August 14, 1961

Members Present: McKibben, Mobley, Peabody, Gamble Fuller, Harris, Haynes, Newton, Edenfield, J. Luce, Pittman and Barrett.

President McKibben presided at meeting. Opened at 2:00 P.M. with prayer by Edenfield.

McKibben instructed secretary to write letters to Mrs. C. B. Bowen concerning the death of her husband and a member of the Board of Trustees, C. B. Bowen, to A. L. Luce, Sr., on his illness, and to George Baker, member of the Board, on his illness.

#### REPORTS OF COMMITTEES:

Cottage Holders' Committee - Edenfield reporting. Application of Oscar Shaw to transfer deed of his cottage to his brother, Alvah Shaw, approved. Application of D. Gorham Jackson to buy cottage of Miss Azalee Jackson (known previously as Hutcherson cottage, lot No. 7) disapproved. Committee had no recommendations on A. O. Allen's application to buy Mays cottage. (Allen had already bought cottage without knowledge of committee). After much discussion, Pittman moved that Edenfield, McKibben, and Harris be authorized to contact Allen relative to his buying cottage and to offer to buy cottage for camp ground, offering him the amount of money he had tied up in cottage. Gamble seconded. Motion passed.

Dr. T. M. Anderson recommended as Bible Teacher for 1962. Report of Committee approved by Board.

grounds Committee - Reported by Harris. No parking lot provided as yet. Walks and streets improved. Sewer system need some work done on it. Electric system needs working on, overloaded as of now. Georgia Power Co. will take over if asked to.

- Music Committee - Reported by Barrett. Recommended that Clay Milby
be called as song leader through 1964 and Joe Crouse be called for
1965 and 1966. Luce moved committee's report be accepted. No Second.
Peabody moved that report be rejected and Clay Milby be called for
1962, 1963 and 1964. No second. It was suggested that each Board
member express himself concerning a change in song leader. Majority
expressed in favor of Milby. Music Committee recommended that Milby
be called for 1962, 1963 and 1964. Board accepted recommendation.

Publicity Committee - Luce reporting. Good publicity given camp ground by editor of newspaper in Jackson, Ga.

Camp Architect - Peabody reporting. Boy's Dormitory cost \$3,499.48.

Youth Work - Peabody reporting. Board and room supplied to young people this year for \$1.00 per day. Much discussion took place concerning entertaining young people next year. Matter continued to next meeting of Board.

Peabody moved that permit be required to increase area of any cottage. Barrett seconded. Motion passed. (Secretary to send notice of this to all cottage holders.)

Treasurer's report made by Newton. (Attached to minutes in hands of secretary). Newton said in better financial condition at this time of year than in previous years. Newton commended for good work.

Haynes moved that a committe be appointed to look into matter of electrical system and report back to mid-winter meeting. Barrett seconded. Gamble offered substitute motion to give Grounds Committee full authority to do whatever necessary to improve electrical system. Pittman seconded. Substitute motion passed. Harris, Gamble and Newton appointed as committee.

Pittman moved that a 24 unit Annex costing approximately \$12,000.00 be erected as soon as finances are available with details left in the hands of committe appointed by president of Board. Barrett seconded. Motion passed.

McKibben appointed Peabody as camp architect to draw up plans for 24 unit annex. Grounds committee and Peabody appointed to look after erection of annex.

Fuller moved that election of new members to Board be deferred to next year. Haynes seconded. Motion passed.

Letter read by secretary from Ralph Foster, Director of Youth work, containing recommendations for your peoples' workers for 1962 and 1963. Peabody moved recommendations be referred to Pulpit Committee. Motion seconded. Passed.

Pittman requested that he be put on retired list. Has served since 1910. Request granted.

Board recessed until Wednesday, August 16, at 2:00 P.M.
