## MINUTES OF BOARD OF TRUSTEES MEETING Indian Springs Holiness Camp Ground Thursday, May 13, 1964 2:00 P.M.

Members present: McKibben, Peabody, Smith, Harris, Fuller, Foster Gamble, Lee, Edenfield, Thome, Walker, Luce and Barrett.

President McKibben presided. Meeting was opened with a prayer by Walker.

Minutes of the last meeting were read and approved.

McKibben read letter of resignation from Mobley, resignation due to ill health. Peabody moved that resignation of Mobley be tabled until August meeting of the board. Lee seconded. Motion passed.

McKibben reported that he had received letter from Mrs. T. M. Anderson stating that Dr. T. M. Anderson could not serve as Bible teacher for 1964 camp meeting due to ill health. Pulpit Committee reported that Dr. Z. T. Johnson had been asked to serve as Bible teacher in Anderson's place for camp meeting of 1964. Luce moved that action of the Pulpit Committee be approved. Seconded. Motion passed.

McKibben reported that all valuable and legal papers of the camp ground are in Lock box 100 at the Social Circle, Georgia bank.

Harris gave Treasurer's Report. No bills due at present. \$3,324.72 in the bank as of May 13, 1964. Two notes due in September, and it is anticipated that these notes will be paid when due.

Luce moved that the young people give to the camp ground treasury half of the money they have left after they have paid all their expenses. Edenfield seconded. Motion passed.

Peabody reported that due to a combination of circumstances beyond control, the work week for the young people will not be held in June as it has been for several years past. It is planned that four or five days before the camp meeting in August that some young people will be present to do some necessary work at the camp.

Luce reported for Publicity Committee. Registration lists are upto-date with 3,500 names on them. Literature for 1964 camp is now ready for mailing and will be mailed out in the next few days.

Edenfield moved that the plaque to be placed on the outside of the cafeteria contain these words - "Luce Memorial Cafeteria." Barrett seconded. Motion passed.

Foster reported that Rev. Thomas Barrett could not be song leader for the youth tabernacle for the 1964 camp meeting. Charles S. Jones has been selected to take his place at the youth tabernacle.

Edenfield reported for the Cottage Holders Committee. The following applications of persons to become cottage holders on the camp ground were approved by the Board:

Mrs. Florence I. Dickinson - Atlanta, Georgia, to take over the Joy Bible Class cottage.

Mr. J. L. Taylor - Covington, Georgia, to build cottage. Mrs. E. S. Cook - Atlanta, Georgia, to buy cottage from Mrs. Aline Hiers.

Mr. J. M. Rustin, Hagan, Georgia, to buy old rest room and convert it into cottage - price to be \$50.00.

Thome reported for Hotel Committee. Old beds in the hotel in bad condition. New beds needed throughout hotel except in the new rooms which were added last year - 1963. Cost of new beds to be \$1,800.00. Peabody moved that new beds for hotel be purchased. Barrett seconded. Motion passed.

Fuller offered to give an electric water heater to the camp ground in exchange for a dozen old beds from the hotel. Board accepted this offer.

Meeting adjourned at 3:45 P.M.
