MINUTES OF THE BOARD OF TRUSTEES MEETING
Indian Springs Holiness Camp Ground
Monday, October 8, 1973

Members Present: Harris, Fuller, Edenfield, Walker, Davis, Ralph Smith, Crouse, Fred Harris, Aycock, Sloat, Glen Smith, Sims, McKenzie, Lindsey, Mayo, Barrett, Brackman, Lee

President Harris presided. Meeting opened with singing of "What A Friend We Have in Jesus" and prayer by Fuller. Devotional consisted of remarks by Frank Harris and testimonies by some members of the Board.

Walker made Treasurer's Report: Cash raised during 1973 camp meeting amounted to \$41,321.63. Pledges made during 1973 camp meeting amounted to \$16,604.00. Debt paid down to \$15,000.00 at Bank in Jackson and to \$2,000.00 on motel - \$17,000.00 still in debt. Less water used during camp this year than last year. Bookstore made a profit of \$1,500.00. \$2,000.00 turned in from hotel. 125 tapes of sermons preached during camp meeting sold. \$3,600.00 turned in from trailer park. All legal papers are in a safety deposit box No. 513 at the C & S Bank in Jackson, Ga.

Barrett moved to make the C & S National Bank and the McIntosh Bank in Jackson, Ga. official depositories of all camp ground funds. Mayo seconded. Motion passed.

Mayo moved to charge \$100.00 for cost of running sewer and water lines to cottages built on the camp ground. Aycock seconded. Motion passed.

Edenfield made Cottage Holders Committee report: Presented applications from Mrs. Mike Patton of Macon, Ga. to place mobile home on the grounds, from Mrs. L.D. Dantzler of Washington, Ga. to place mobile home on the grounds, and from Mr. & Mrs. Clifton P. Jenkins of Decatur, Ga. to buy cottage from Mrs. Mike Patton. Aycock moved approval of applications. Motion seconded. Passed.

Secretary read letter of appreciation from Rev. & Mrs. O.B. Bankston for love offering given to them during camp meeting in August. Also read letter of invitation to lunch (free of charge) at caretaker's cottage from the Bankston's.

Harris reported that a timber cruiser had been on the grounds and that he said timber wasn't ready for cutting now, to wait 3 or 4 years before cutting timber.

Lindsey moved that young people be charged \$2.00 per day for staying on the grounds during camp meeting. Edenfield seconded. Passed.

Mayo moved to proceed with repairs on girls' dormitory subject to approval of Executive Committee relating to cost. Aycock seconded. Passed.

Fuller moved that Treasurer of camp ground be authorized to borrow up to \$25,000.00 for necessary expenditures on camp ground. Glen Smith seconded. Passed.

Walker moved that bus station be moved from present location at entrance to grounds to trailer park. Mayo seconded. Passed.

Walker moved that necessary improvements at entrance to camp ground be

made. Seconded. Passed.

Walker reported that the Bankston's were moving back into their cottage on the grounds, and moved that Board approve Glen Walker moving into the caretaker's cottage as a watchman for the grounds. Seconded. Passed.

Harris reported that Walker will look after camp ground for 1973-74.

Fuller reported for Pulpit Committee: Rev. Lawrence B. Hicks recommended as preacher for main tabernacle in near future. Seconded. Passed.

Barrett reported for Music Committee: Rev. Joe Crouse will be song leader for 1975 camp meeting.

Harris reported that he had asked Bishop William R. Cannon to preach on the first Sunday afternoon at 1974 camp meeting.

Sloat reported for Annex Committee: All rooms reserved for 1974 camp meeting except four.

Aycock reported for Cafeteria Committee: \$652.23 deficit in finances for 1973 camp meeting in cafeteria. Mrs. L.D. Dantzler will be in charge of cafeteria with her crew for 1974 camp meeting.

Glen Smith reported for Bookstore Committee: Suggested that Board members bring their used books they no longer want to camp meeting in 1974 and donate them to bookstore. They can sell for 50¢ or \$1.00.

Meeting adjourned with prayer by Mayo.

Next meeting of Board of Trustees will be May 14, 1974.
