MINUTES OF THE BOARD OF TRUSTEES MEETING
INDIAN SPRINGS HOLINESS CAMP GROUND
Tuesday, October 14, 1975

Members Present: Frank Harris, Fuller, Davis, Aycock, Barrett, Batchelor, Crouse, Fred Harris, H. Johnson, Lindsey, Luce, Sims, Smart, R. Smith

President Harris presided. Meeting opened with singing led by Lindsey and devotion by Frank Harris and prayer by Barrett.

Mr. & Mrs. Benjamin Mays appeared before Board for approval to purchase the Rustin cottage. Rev. Brooks Partain appeared for approval to place a mobile home on the grounds. Both were approved as cottage holders.

Frank Harris welcomed Dr. Hiram Johnson as a new member of the Board.

Davis made Treasurer's report: Balance on hand \$6,251.45.

Report was read from Annex Committee.

Discussion took place on speaker system. Joe Luce appointed to resolve future problems.

Missionary Day report given. Johnson appointed to make recommendations on improvements at the May meeting of Board.

Motion made by Luce to give prerogative to ask for a night missionary service. Seconded by Barrett. Passed.

Sims made Bookstore report in absence of G. Smith: (copy included).

Smart made Cafeteria Committee report: (copy included)

Motion was made by Sims to write Mrs. Norris McKenzie a letter of appreciation for a job well done in the cafeteria during 1975 camp meeting. Seconded. Passed.

Lindsey made Youth Committee report: Ted Holly approved as evangelist for youth tabernacle.

H. Johnson made Nursery report.

Fuller made Pulpit Committee report: Bible teacher for 1976 - Rev. Andy Miller. Recommended as future preachers for main tabernacle Rev. Bill McCumber, Rev. Leslie Parrott, Rev. John Oswalt. Recommendations accepted.

Motion made by Barrett to notify Rev. Charles Williams of his change in preaching appointment in main tabernacle. He is moved down in the schedule and notified later as to when he will be scheduled. Smart seconded. Passed.

Fuller led discussion of Board make-up.

Luce made Buildings & Grounds Committee report: Crouse moved to accept proposal for asphalt paving of streets on camp ground. Barrett seconded. Passed.

Administration Building plans not yet ready. Permission to plan for George Mathews prayer chapel asked by Luce. Granted. Family will pay cost.

Permission to borrow money for capital improvements up to \$20,000.00 given Treasurer.
