**Introduction**

The United Christian Ashrams, International Records span the years 1951 to 1996 with a concentration of materials between 1965 and 1986. The items in the collection revolve primarily around the activities of the General Secretaries who were William Richardson, Paul Wagner, and Lawrence Lykens.

The collection is composed of proceedings, correspondence, subject files, reports, literary productions, legal documents, financial documents, printed material, and photographic material. The majority of the collection is contained in the correspondence. This primarily involves the three General Secretaries listed above. The minutes contained in the proceedings section and the financial documents give insight into the yearly activities of the United Christian Ashrams, International. The legal documents primarily contain information from various wills which contain gifts to the United Christian Ashrams, International.

This collection was processed by Jonathan Mikesell in the Fall of 1996. The finding aid was prepared by Jonathan Mikesell in January 1997.

**Bibliographic Sketch**

Ashrams have been known in India for centuries. Dr. E. Stanley Jones gave the Ashram a Christian connotation and established the United Christian Ashrams in India in 1930. He brought it to the United States in 1940. The United Christian Ashrams are designed to spread the Gospel of Jesus Christ and to deepen the spiritual lives of those who are willing to witness and to serve as lay and ordained men and women. This is done by conducting meetings in local geographic areas known as Christian Ashrams under the direction of dedicated Christian leaders and teachers. Of particular importance for Christian Ashrams is the place of prayer during these meeting times. Dr. Jones believed that such experience could help individuals to grow and to be strengthened for Christian living, witness, and mission. The Ashram movement is an international movement with national and local Ashrams in many countries in Europe, Asia, Africa, North and South America, and Australia. ("The Golden Jubilee Fund," James Mathews; Directory of Religious Organizations in the United States, 1982)

From the 1940's until the early 1970's, Dr. Jones was the leader of the United Christian Ashrams. Prior to his death in 1973, he established a system of government which would allow for the perpetuation of the Ashram movement. The board of directors was selected and became self-perpetuating. Along with this board, Bishop James Mathews, son-in-law of Dr. Jones, was named the permanent chairman of the United Christian Ashrams as long as he was able to carry out his duties. Dr. Jones, known in Ashram circles as Brother Stanley, also appointed a group known as the FOUR to help maintain the "soul" of the Ashram movement during this time of transition. At the time of Dr. Jones' death, there were also two other officers: the General Secretary and the Treasurer. Both of these individuals were

volunteer and both received small honorariums for their work. In 1975, the office of "Director of the United Christian Ashrams" was established on a volunteer basis. This position was later renamed "The Coordinator of North America." As the movement grew in North America, seven regions were developed with coordinators for each to direct the activities. These coordinators were volunteers who were given funds to cover some of their travel expenses. Later, a "field representative" was selected to assist in the establishment of Ashrams in certain areas of North America so that the travel expenses of the Coordinator of North America could be reduced. The office of "Director of the E. Stanley Jones Associates for Evangelism" was also created to develop the Ashram movement in local churches and communities. Such was the structure of the united Christian Ashrams during the time of the majority of material in this collection, namely 1965 to 1986. ("Development of the United Christian Ashrams," Paul Wagner)

### Scope and Content

The United Christian Ashrams, International Records span the years 1951 to 1996. The majority of the collection, however, is from 1965 to 1986. It generally revolves around the materials collected by the three General Secretaries of this period; William Richardson, Paul Wagner, and Lawrence Lykens. It is particularly strong from 1976 to 1986 when Paul Wagner and Lawrence Lykens were in office.

The **Proceedings**, comprising .3 cubic feet, include articles of incorporation, constitution and by-laws, and minutes. This latter section includes minutes from meetings of the board of directors, a conference call, the executive committee, the four, and the seven.

The **Correspondence** contains 4.5 cubic feet of material. This material is arranged by the major person involved in the writing. Thus, all correspondence to and from, for example, Paul Wagner is together so that the conversation between the individuals involved is easily found. The majority of these materials involve Paul Wagner, 2.0 cubic feet (including .4 cubic feet between Wagner and Lykens), and Lawrence Lykens, 1.8 cubic feet. The remaining .7 cubic feet contain correspondence of William Berg, Harold Dutt, Gordon Hunter, E. Stanley Jones, James Mathews, H.H. McConnell, James Pemberton, William Pickard, William Richardson, John Roberson, J.T. Seamands, James Sells, and O.B. Spencer.

The **Subject Files** include .4 cubic feet of information. This material gives helpful background material on various aspects of the Ashram movement. Of particular help is the general historical material about the Ashram movement. Also included are items regarding foreign Ashrams in Fiji, Haiti, and Jamaica; the E. Stanley Jones Foundation; and the United Christian Ashrams Foundation. A final useful part of this section is its inclusion of background material on such important Ashram leaders as Lawrence Lykens, James Mathews, William Richardson, and Paul Wagner.

The **Reports** section comprises .1 cubic feet of the collection. This material gives insight into the activities of the Coordinator of North America, the Director of Finance, the General Secretary, and the Treasurer.

The **Literary Productions** in this collection comprise only two folders. They contain two articles written by E. Stanley Jones about Ashrams.

The **Legal Documents** make up .1 cubic feet of this collection. They primarily include wills and other legal documents relating to various estates in which gifts were made to the United Christian Ashrams.

The **Financial Documents** in this collection comprise 1.0 cubic feet. This material generally includes Daily Journals and Petty Cash journals. It also includes the ledgers of various segments of the Ashram movement used to maintain financial records. Also included are monthly treasurer's reports.

The **Printed Material** section comprises .8 cubic feet of this collection. The majority of this material is related to the packets of information distributed at the annual meetings of the Board of Directors and the Executive Committee. From 1976 to 1980, these two groups were issued separate packets of material. However, from 1980 to 1985, bound yearly reports and workbooks were issued.

The **Photographic Material** in this collection includes only two folders. These pictures include the Whitehead Property, which was a gift to the Ashram movement, and apparent promotional photographs of Kenneth S. Cummings.
