MINUTES OF THE BOARD OF TRUSTEES MEETING
Indian Springs Holiness Camp Ground
Tuesday, May 11, 1976

Members Present: Harris, Fuller, Edenfield, Davis, Barrett, McKenzie, Ralph Smith, Batchelor, Smart, Brackman, Lindsey, Sims, Fred Harris, Hiram Johnson, Luce, Sloat, Lee

President Harris presided. Meeting opened with prayer by McKenzie.

Edenfield made Cottage Holders Committee report: Rev. Paul Bell of Dudley, Ga. applied to place mobile home on grounds. Bell was present, and was introduced to Board. He made statement as to why he wanted to become a cottage holder at Indian Springs. After statement, Davis moved to approve Bell as a cottage holder. Lindsey seconded. Passed.

Mr. Tommy Davis applied to buy cottage from father, Hoyed Davis. Davis was present and introduced to Board. He made statement as to why he wanted to become a cottage holder at Indian Springs. After statement, Lindsey moved approval of Davis as a cottage holder. Barrett seconded. Passed. Discussion then took place concerning rule passed by Board previously to require prospective cottage holders to appear personally before Board to state their reasons for wanting to become cottage holders at Indian Springs. After much discussion, Sims made motion to rescind rule. Edenfield seconded. Passed.

Luce moved that a questionnaire be drawn up by Cottage Holders Committee, said questionnaire to be sent to references furnished by applicants who want to become cottage holders on the grounds. Barrett seconded. Passed. This questionnaire to be shown to the Board at its August meeting for its approval or disapproval or for changes to be made in it.

Application of Mr. & Mrs. Charles Darnell to place a mobile home on the grounds was presented. Approved.

Application of Mrs. Irvan Middlebrooks to buy Mrs. Susie Hughes cottage was presented. Approved.

Application of Mrs. Lucy Naylor to become owner of Mrs. Edwards mobile home was presented. Approved.

Application of Mrs. Mary McAfee Hardwick to become owner of H.H. McAfee cottage was presented. Approved.

Luce discussed the matter of making more lots available for mobile homes. It was agreed that this be done.

Fuller made Pulpit Committee report: Evangelists for 1977 are: Harold Loman, Paul Rader, Leslie Parrott. Evangelists for 1978 are: Jimmy Lentz, Andy Miller, David Seamands.

Dr. Dennis Kinlaw cannot come in 1979. Morton Dorsey recommended to fill vacancy. It was decided to wait until August meeting of Board to fill vacancy. Luce suggested Eldon Fuhman for 1979. The other evangelists for 1979 are: Kenneth Frazier, W.E. McCumber.

Dennis Kinlaw was recommended for 1980 (can't come until Monday of camp meeting). John Brackman recommended to fill in for first three days of camp meeting until Kinlaw arrives. Kinlaw and Brackman approved for 1980. Harold Loman and Bill Coker approved for 1980.

Lindsey moved that Charles Williams be approved as evangelist for 1981 on condition he ~~not-remarry-by~~ is not remarried by that year. Barrett seconded. After much discussion of motion, Fred Harris moved that motion be tabled. Sims seconded. Passed.

Fuller requested permission to be allowed to live on grounds year round. Sims moved approval of request. Barrett seconded. Passed.

Davis made Treasurer's report: Written report handed in. A very good report. \$5,000.00 in debt. Lindsey moved acceptance of report with appreciation. Seconded. Passed.

McKenzie made Cafeteria Report: Improvements needed before camp meeting.

Luce reported will buy new amplifier for main tabernacle public address system before camp meeting.

Hiram Johnson reported for Missionary Day Committee: Mr. Doug Carter is to be speaker. He is associated with the World Gospel Mission.

Matter of providing cottage for second caretaker brought up. Luce to investigate matter and report to August meeting of Board.

Brackman reported for Book Store Committee: Glenn Smith to do recording as usual. Jack Howell and Brackman to run bookstore this year.

Luce moved purchase of new recording equipment. Barrett seconded. Passed.

Luce reported that a college student has been hired for one month to get camp ground ready for camp meeting in August.

Meeting adjourned with prayer by Fuller.
