MINUTES OF THE BOARDNOF TRUSTEES MEETING Indian Springs Holiness Camp Ground Wednesday, August 6, 1980

Members Present: Frank Harris, Luce, Edenfield, J.W. Lee, Newby, Smart, Andrews, McKenzie, Aycock, Barrett, Crouse, Batchelor, G. Smith, Sims, H. Johnson

President Harris presided:

Sims presented ballots for voting for officers and Trustees. Voting took place with the following men melected as officers for 1980-81:

President - Frank Harris Vice-President -- Joe Luce Secretary - R.O. Edenfield Treasurer - Hoyed Davis

The 5 Trustees whose terms expired this year were re-elected for a four-year term as follows: Don Andrews, Paul Barrett, R.O. Edenfield, T.E. Newby, Roy L. Sims. 4 new Trustees were elected as follows:

Mr. Irven Middlebrooks
Mr. Cecil Zwiefel

Two men received an equal number of votes. Aycock moved these two names be drawn, the first one drawn being elected for a term of two years, and the second one drawn be elected for a term of one year. The mannet ceiving the highest number of votes be elected for a term of four years, and the man receiving the second highest number of votes be elected for a term of three years. Seconded. Passed. This addition of four new Trustees brings the number of Trustees to 24.

Edenfield made Cottage Holders Committee report: Two applications were submitted to become cottage holders on the camp ground - Mr. Hildreth Kenerly of Smyrna, Ga. and Mr. Brady Boling of Marietta, Ga. These persons want to buy the "Papa Dan" cottage (now owned by the Martha Brannan United Methodist church in Atlanta). Luce moved approval of these two persons. Barrett seconded. Passed.

Aycock brought up matter of Thanksgiving Day service on Wednesday each year. Suggested emphasizing this service more than in past. aBoard will think about ways of doing this and discuss it at October meeting of Board. Aycock also suggested installing two microphones on floor so people who testify during Peoples Meeting can use them so that their testimony can be heard over the tabernacle. Suggested having some music or singing by congregation or choir during taking of offering at regular services.

Meeting adjourned with prayer.
